

- D.** If any student to any of these courses leaves the course any time after 90 calendar days after his admission to that particular course in a particular academic year, he will be required to pay full amount of tuition fees for the remaining entire duration of his course (i.e. 3 years or as the case may be)
- E.** Under no circumstances other fees paid by the student will be refunded either in part or full except the amounts of college development fund.


